Graduation Requirements Basic Graduation Requirements

- 1. A student must earn a minimum of 200 credits in courses approved by the GCC for high school credit in order to graduate. The grade point average (GPA) on all credits counted toward graduation shall not be less than 1.0 on a 4.0 scale. Courses offered by the GCC for high school credit usually award five (5) credits for each course completed each semester.
- 2. The minimum of 200 credits for graduation from high school shall include:

Certificate of Completion:

A Certificate of Completion is an option for all special education students. Course work has been developed within the special education department for students to achieve this certificate. Courses focus on those skills needed for independent living. Students should be working on meeting their IEP goals in each area as determined by the IEP team. Students who are working toward a Certificate of Completion participate in

graduation ceremonies with their general education peers. No distinction is made between a diploma and certificate at the ceremonies.

Any courses may be taken on a pass/fail basis for students who are **not** working towards a diploma.

Timeline for students: The table below details when a student is no longer eligible under the Individuals with Disabilities Education Act (IDEA) to receive specialized instruction and related services through an IEP. The table below lists the guidelines regarding terminating special education services. A prior written notice (PWN) is required upon the termination of special education services.

If the student's 22nd birthday is between January and June, the student may continue through the remainder of the fiscal year (school year and extended school year (ESY) ending July 1).	EC 56026(c)(4)(A)
If the student's 22nd birthday is in July, August, or September of the new fiscal year, then the student may not begin a new fiscal year (school year and ESY ending July 1 of this year).	EC 56026(c)(4)(B)
If the student's 22nd birthday is during October, November, or December, the student shall be terminated from the program on December 31 of current fiscal, unless the student would otherwise complete his or her IEP at the current fiscal year.	EC 56026(c)(4)(c)
The student graduates from high school with a regular high school diploma.	EC 56026.1(a)
