## Plan Summary [2024-25]

### General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Higher Learning Academy (HLA) first opened its doors to students in 2005. HLA is a public charter school currently serving grades Transitional Kindergarten through eighth with 530 students. HLA is located in the geographical area of North Sacramento; this area includes the communities of Ben Ali Neighborhood, Del Paso Heights, Robla, Rio Linda and Natomas. This area is a mixed use rural and urban area that supports a variety of light industrial businesses and also small residential homes. HLA serves a high needs population with 92% considered unduplicated. The median household income in the zip code is 15K less than Sacramento County.

HLA is a school of Gateway Community Charters and overseen by the GCC governing board and Superintendent/CEO. HLA challenges scholars with a rigorous, college preparatory curriculum. Both the elementary and middle school curricula align to Common Core State Standards and all other adopted state standards. Scholars learn 21st Century skills that are incorporated into the International Baccalaureate (IB) framework. HLA is an authorized IB World School for the Primary Years Program and is seeking authorization for the Middle Years Program as well. HLA is a WASC-accredited school.

### Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

HLA saw positive gains in 2023 for many subgroups, moving the school out of ATSI. Chronic absenteeism moved from "very high" to yellow, with African American, English learner, SED, and white students moving out of the "very high" designation. In ELA, African Americans, SED, and white students moved out of the lowest designation and into orange, orange, and yellow respectively. In math, African Americans, English learners, and SED students moved from very low to orange, while white students moved from very low to yellow. Overall, math scores increased by an average of 11.7. In ELA, English learners as well as the Hispanic subgroup are still in red. In math, no subgroups are in the red.

We are still not yet satisfied with only 18% of our scholars meeting or exceeding standard in ELA, nor are we satisfied with 7% of scholars meeting or exceeding standard in math. In order to support all scholars, we are have identified essential standards and put tier 2 and 3 interventions in place. Teachers are already planning instruction for 2024-2025 with these essential standards in mind. Common formative assessments will guide our instruction and interventions with all scholars. We have hired an intervention teacher to help us manage and

implement tier 3 interventions. We have also been trained on tier 1 of PBIS. We'll be implementing fully next year. We anticipate that these behavior systems will set up our scholars for success in the classroom by minimizing unwanted behavior.

  - This amount is the Total Estimated Actual Expenditures for Contributing Actions (7) subtracted from the Total Planned Contributing Expenditures (4).
- **5. Total Planned Percentage of Improved Services (%)**
  - This amount is the total of the Planned Percentage of Improved Services column.
- **8. Total Estimated Actual Percentage of Improved Services (%)**
  - This amount is the total of the Estimated Actual Percentage of Improved Services column.
- **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**
  - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**

- This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
  - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**
