

School districts receive funding from different sources: state funds under the Local Control Funding Formula (LCFF), other state funds, local funds, and federal funds. LCFF funds include a base level of funding for all LEAs and extra funding - called "supplemental and concentration" grants - to LEAs based on the enrollment of high needs students (foster youth, English learners, and low-income students).

Budget Overview for the 2020-21 LCAP Year




This chart shows the total general purpose revenue Empowering Possibilities International Charter (EPIC) expects to receive in the coming year from all sources.

The total revenue projected for Empowering Possibilities International Charter (EPIC) is \$5,959,872, of which \$4,196,156 is Local Control Funding Formula (LCFF), \$555,405 is other state funds, \$321,839 is local funds, and \$886,472 is federal funds. Of the \$886,472 in federal funds, \$488,051 are federal CARES Act funds. Of the \$4,196,156 in LCFF Funds, \$1,099,923 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

For the 2020-21 school year school districts must work with parents, educators, students, and the community to develop a Learning Continuity and Attendance Plan (Learning Continuity Plan). The Learning Continuity Plan replaces the Local Control and Accountability Plan (LCAP) for the 2020–21 school year and provides school districts with the opportunity to describe how they are planning to provide a high-quality education, social-emotional supports, and nutrition to their students during the COVID-19 pandemic.



This chart provides a quick summary of how much Empowering Possibilities International Charter (EPIC) plans to spend for planned actions and services in the Learning Continuity Plan for 2020-2021 and how much of the total is tied to increasing or improving services for high needs students.

Empowering Possibilities International Charter (EPIC) plans to spend \$5,935,392 for the 2020-21 school year. Of that amount, \$387,381 is tied to actions/services in the Learning Continuity Plan and \$5,548,011 is not included in the Learning Continuity Plan. The budgeted expenditures that are not included in the Learning Continuity Plan will be used for the following:

The expenses outlined in the Learning Continuity Plans were specific and targeted to supports to students during distance learning. Expenditures continue for high needs students as outlined in the LCAP goals and actions. Additionally, the general fund costs not specified or included in the LCAP range widely from basic supplies to general facilities costs & maintenance as well as service agreements and administrative and staff salaries


Increased or Improved Services for High Needs Students in in the Learning Continuity Plan for the 2020-2021 School Year

In 2020-21, Empowering Possibilities International Charter (EPIC) is projecting it will receive \$1,099,923 based on the enrollment of foster youth, English learner, and low-income students. Empowering Possibilities International Charter (EPIC) must describe how it intends to increase or improve services for high needs students in the Learning Continuity Plan. Empowering Possibilities International Charter (EPIC) plans to spend \$374,261 towards meeting this requirement, as described in the Learning Continuity Plan.

Additional services include: staffing to support high need students with individualized instruction and small groups. Supports for students with technology, curriculum and other targeted interventions to ensure student academic progress as well as social emotional support as needed.

Update on Increased or Improved Services for High Needs Students in 2019-20



This chart compares what Empowering Possibilities International Charter (EPIC) budgeted in the 2019-20 LCAP for actions and services that contributed to increasing or improving services for high needs students with what Empowering Possibilities International Charter (EPIC) actually spent on actions and services that contributed to increasing or improving services for high needs students in the 2019-20 school year.

In 2019-20, Empowering Possibilities International Charter (EPIC)'s LCAP budgeted \$896,917 for planned actions to increase or improve services for high needs students. Empowering Possibilities International Charter (EPIC) actually spent \$848,582 for actions to increase or improve services for high needs students in 2019-20.

Due to the shelter in place order issued in March 2019, EPIC was unable to expend funds as originally planned. The services are still being provided but the cost was not as great as originally budgeted because of the shelter in place order
