




This chart shows the total general purpose revenue Futures High School expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Futures High School is \$8,131,676, of which \$7,143,308 is Local Control Funding Formula (LCFF), \$146,370 is other state funds, \$384,834 is local funds, and \$457,164 is federal funds. Of the \$7,143,308 in LCFF Funds, \$2,099,223 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



## **Plan Summary [2023-24]**

#### **General Information**

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Futures High School is an independent charter school located in the Sacramento area serving approximately 500 students in grades 9-12 since 2004. Twin Rivers Unified School District (TRUSD) is Futures' authorizing school district. In the fall of 2016, Futures submitted an updated charter petition to the district for the approval. The school met all criteria for charter renewal and was approved by the TRUSD for additional five years on December 13, 2016. The school moved to a brand new site in the fall of 2018. With the move, the school's enrollment declined from 400 to 350 but quickly increased again and has maintained over 400 students since 2020. The school worked diligently on supporting the students through this transition and was able to retain most student who attended Futures high School prior to the move. The school serves high number of low socio-economic disadvantaged students who are vulnerable to any changes in local and state economy and a significant number of English Learners, many of which are brand new immigrants attending public school in the United States for the first time.

Futures was established by community leaders who wanted to give students a path to transition into a career after completing high school, and parents who wanted a high-quality charter school which prepared their children for the rigor of college and/or university. Moreover, the parents expect the school to be a safe place for immigrant students to begin their acculturation into American society. In the last year, Futures experienced a notable increase of special education students. Futures is under the El Dorado Charter SELPA umbrella and employs a full time RSP teacher and full time RSP para to serve the needs of students with disabilities. The El Dorado Charter SELPA provides professional learning to staff and administrators, Alternative Dispute Resolution tools and assistance, facilitation of root cause analysis for Program Indicator Review and other Special Education accountability measures.

#### **Reflections: Successes**

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

When we compare the results of diagnostic 1 and 2 for both the 2021-2022 and 2022-2023 school years, the data reveals some positive trends. First, there has been an increase in the number of students completing the math test, indicating better participation rates. Additionally, there has been an overall growth in the proportion of students scoring at or above the mid-grade level and early on grade level. This suggests an improvement in math skills among the students. Moreover, the data also demonstrates a decrease in the number of students scoring three or more grade levels below, indicating a reduction in the prevalence of low-scoring students.

Shifting our focus to the Reading subject, a similar analysis comparing the results of diagnostic 1 and 2 for both school years highlights some noteworthy findings. Firstly, there has been an increase in test completion rates, indicating improved engagement among students. Furthermore, there has been an overall decrease in the number of students scoring three or more grade levels below, which signifies progress in reading abilities.

In the 2021-2022 school year, when comparing the Reading results for diagnostic 1 and 2, we observe growth in the proportion of 9th, 10th, and 11th graders scoring at or above the mid-grade level and early on grade level. This suggests an improvement in reading skills among these grade levels.

Moving on to the 2022-2023 school year, the data reveals an increase in growth specifically for 9th and 10th graders scoring at or above the mid-grade level and early on grade level in Reading. This indicates that these particular grade levels have made progress in their reading abilities compared to the previous year.

Overall, these findings demonstrate positive trends in both Math and Reading. The data reflects increased test completion rates, improvements in the performance of students at mid or above grade levels, and a decrease in the number of students scoring significantly below grade level. These positive outcomes highlight the success of the educational efforts and interventions implemented during the analyzed school years.

#### The dashboard for 2021-2022

- While the Dashboard reports our suspensions rates are "high," Futures has successfully lowered our suspension rates by 3% between 17-18 and 21-22 school years.
- Futures graduation rate has fluctuated over the years, especially during the 19-20 year with the passage of AB104 allowing students to graduate with reduced credits due to COVID19 school closures. Overall, Futures High School graduation rate has been at or exceeded the statewide total graduation rate for three of the last four years
- College and career indicator was not reported on the 2022 dashboard.

Local school data shows the following success:

iReady Math Assessments: local indicators show that the percentage of students "at or above grade level" grew from 9% to 22% of students schoolwide and the percentage of students "three or more grade levels below" decreased by 13%. Low SES at/above grade grew from 9% to 21% and "three or more grade levels below" decreased from 60% to 46%. EL at/above grew from 1% to 12% and "three or more grade levels below" decreased from 77% to 57%.

iReady ELA Assessments: local indicators show that the percentage of students "at or above grade level" grew from 15% to 20% and the percentage of students "three or more grade levels below" decreased by 10%. Low SES at/above grade grew from 14% to 19% and "three or more grade levels below" decreased from 65% to 56%. EL at/above grew from 1% to 5% and "three or more grade levels below" decreased from 90% to 76%.

#### **Reflections: Identified Need**

LEA needs to improve College and Career indicators specifically CTE pathways completion. Even though the most recent Math performance data is not available, previous data and local indicators show that the students' performance in Math needs to be improved as well. Moreover, based on the local indicators such as surveys, parent, teacher, and student reports, focus on SEL is necessary to aid in reducing achievement gap that resulted in the previous year distance learning time.

#### **LCAP Highlights**

The LCAP goals directly correlate with the school's mission, state priorities, and WASC action plan. Based on the students' needs and the current data, the school consolidated the LCAP goals into three overarching themes: 1) College and Career, 2) Academics, and 3) Culture and Climate. Academics will include a primary focus on further developing our ELD program, including a comprehensive professional development program for all staff, which will center on both differentiation and the effective use of technology instructional tools. Development of a 3-course NGSS model, and additional Project Lead the Way opportunities will bolster our already strong science core. Math highlights include additional support for the Integrated Math courses, with hands-on math projects being designed and implemented. Our English department will provide support to all staff as Futures continues its focus on DOK across the curriculum. College and Career goals include additional test preparation support, as well as the creation of a PLTW CTE pathway. In addition, Futures will be developing a comprehensive, cross-curricular, cross-grade-level model to address all facets of college and career readiness. Culture and Climate highlights include providing a safe environment that is conducive for students' emotional and physical well-being furthering student 'Voice

and Choice' on campus, as well as increasing the level of social-emotional support for students through integration of an SEL (Social Emotional Learning) model.

## **Engaging Educational Partners**

In developing our Local Control Accountability Plan (LCAP) the school sought input from various stakeholders to ensure that the plan comprehensively reflects how the needs of all students are going to be addressed according the the state priorities. March 2023- GCC School Board meeting was held, where mid-year report on LCAP was presented. The Assistant Superintendent presented an abbreviated mid-year update of the GCC's LCAP progress. Funding predictors for Gateway Community Charters were given, and stakeholders had the opportunity to ask questions and provide feedback about the LCFF and LCAP. The school administration and leadership team completed a matrix relating to how goals in the SSD plan, WASC plan, Gateway Community Charters (GCC, Charter Management Organization) GCC core commitments, and the charter petition, aligned with the eight State priorities under the LCAP.

Futures' schoolwide planning for WASC and LCAP was a collaborative effort between all stakeholders. All staff were involved with giving input on the progress of the action plan and making suggestions for future actions. The leadership team, consisting of the principal, vice principal, instructional coach, and one head from each department, was also active in giving input on programs and progress. Parent engagement is slowly increasing, as Futures has recently joined the PFO of the other school on our site. Through the PFO and School Site Council, parents are consulted on a regular basis to gather feedback on data, comprehensive needs, budget development, and the Family Engagement Policy. Parents are also engaged in school-wide information through parent nights, groups such as our monthly equity meetings, and special meetings, such as our upcoming parent meeting to revise our mission and vision. Parent Square is also used to share important information and to solicit feedback. For example, The WASC action plan was provided to families through Parent Square. While input on school programs is given in a variety of ways, the new school leadership is taking steps to systemize the process of reviewing the WASC action plan on a set schedule.

#### A summary of the feedback provided by specific educational partners.

The stakeholders provided a comprehensive input into the LCAP development. The staff, students, and parents, met regularly to clarify the needs and articulate goals and actions for the strategic planning. During school site council meetings, all stakeholders are represented and are given the platform when speaking about the needs of the school. Before any decision is made, the administration team collaborates with all stakeholders to provide equitable voice.

#### A description of the aspects of the LCAP that were influenced by specific input from educational partners.

The feedback from the stakeholders impacted the LCAP directly. The programs and resources were aligned to ensure that the needs of all students are addressed, specifically the identified significant subgroups of students who struggled the most. Providing safe environment, high-quality curricular and supplementary resources, consistently utilize specifically designed instructional practices, and use data informed practices and make data informed decisions were all key aspects educational partners wanted to see in the LCAP.

An explanation of how effective the specific actions were in making progress toward the goal.

Local indicators show an area of growth in both ELA and Math and Futures supported this need by providing resources and support to teachers. Specifically, with actions such as professional development, data platforms and an increase in paraprofessional support, (1.2, 1.3) Futures was able to better serve our EL's with reading, writing and math. Futures also added three teachers to be trained in PLTW engineering courses to continue with the CTE pathway and increased summer school offerings (1.1, 1.13). All of these actions helped ensure that FHS students are college and career ready.

To meet the needs of our expanding EL population, Futures added an ELD teacher position and a paraeducator (1.1, 1.2, 1.5). The addition of the ELD position helped create manageable class sizes for ELD classes. Paraeducators pushed in to support ELD and content classes to ensure EL students received instruction within their zone of proximal development. ELs also continued to receive support through technology and digital curriculums (1.5) and print resources (1.11) to ensure appropriate scaffolding support for academic success. Futures also taught digital literacy through content classes, as the school is 1:1 for chrome books (1.12) and utilizes a number of software programs.

Administrators attended training and professional development (1.10) that helped prepare them to lead the work on equity, with the support of necessary resources (1.6). Equity work brought greater awareness and action for ensuring a safe and equitable environment to ensure students can focus on their academic studies.

The implementation of specific actions played a crucial role in advancing the goal of supporting classified staff in creating a safe and clean environment while increasing student support for college and career readiness. By allocating resources and supplies, school campuses were equipped with the necessary tools to provide an effective learning environment.

In addition to professional development, the allocation of funds towards programs and instructional resources specifically designed to support college and career readiness played a vital role in preparing students for their future endeavors. These resources included career and technical education programs, expanded elective courses, and enriched world language offerings. By broadening the educational pathways available to students, they were equipped with a diverse skill set and a comprehensive understanding of various disciplines, thereby increasing their readiness for both college and career success. These courses, in turn, were supported through necessary curricular and supplemental resources (1.4, 1.8) and teacher support and training (1.9).

Overall, the effective implementation of these specific actions, including resource allocation, professional development, program funding, and event organization, significantly contributed to the goal of supporting staff in creating a safe and clean environment while increasing student support for college and career readiness. These initiatives fostered an enriched learning environment, equipped staff with the necessary skills and knowledge, provided students with diverse educational pathways, and actively engaged them in their own college and career exploration.

Futures successfully implemented an expanding number of course options and programs to support the varying needs of all students. (2.7, 2.9, 2.12, 2.10). Included within the programs at Futures are acceleration and remediation opportunities (2.6, 2.8, 2.10) this led to a strong graduation rate and A-G completion.

Futures was effective with helping to connect students and families to community resources through different workshops and counseling (2.2, 2.5, 2.11). Futures was also effective with awareness of college and career through different fields trips and SEL counseling (2.1, 2.4). Foreign language classes offered to students helped with the seal of biliteracy testing.(2.3)

Goal 1: Develop College and Career Ready students, Actions 1-6:

These actions provides funds for professional development and curriculum to support teacher/staff in development to increase knowledge of pedagogical best practices and academic intervention practices that will support EL, homeless, foster, SPED and low-income students. School staff will be trained in effective teaching strategies, including culturally relevant teaching practices, to ensure quality instruction is delivered to all students. Our most vulnerable students often experience anxiety and depression and have a difficult time maintaining adequate academic progress throughout the school year. Many of our students are refugees, EL, low income and foster students and some have high numbers of Adverse Childhood Experiences (ACE's) and need extra support focused on Social Emotional Learning (SEL). This goal will also provide staff with developed knowledge around state standards directly tying this to EL curriculum and other core content areas for direct support for EL, foster and homeless youth. Futures will continue to be innovative on increasing graduation rates.

Goal 2: Increase academic growth, achievement and enrichment opportunities for all students, as well as close achievement gaps with underperforming student groups. Actions 1-6:

This goal and these actions provide funds for use of data systems such as Aeries and iReady to support ongoing assessment, data collection and analysis of academic and SEL needs specific to EL, foster, and low-income students. This data will be used to plan interventions, program changes, and increased services for these populations. Futures has a high percentage of EL, low income and foster students needing academic and counselor support. These students often experience anxiety and depression and have a difficult time maintaining adequate academic progress throughout the school year. Many of our students are refugees, EL, low income and foster students also have high numbers of Adverse Childhood Experiences (ACE's) and need extra support focused on Social Emotional Learning (SEL). Providing professional learning to school staff through our coherence work will help ensure that the systems of support we put in place for these students is effective, efficient and helps to create positive learning outcomes for our most vulnerable student populations.

GOAL 3: Foster a positive culture and climate through providing a safe, healthy and engaging learning environment, Actions 1-6:

Futures students have high numbers of Adverse Childhood Experiences (ACE's) and need extra support focused on Social Emotional Learning (SEL). Futures staff will use these data systems to continually evaluate the effectiveness of implementation of academic and SEL supports for special populations. This action provides funds for professional learning, coaching and leadership support to ensure connections of all systems and programs within the Futures organization to support student learning outcomes. Futures has also been approved for a social worker and intervention teacher that will help with the needs of all students.

A description of how services for foster youth, English learners, and low-income students are being increased or improved by the percentage required.

LEA increase services to EL students by improving data analysis practices and data systems to ensure that the progress is monitored regularly and inform instructional practices as well as inform strategic planning. ELD teacher and paraeducators who serve students in ELD courses, Math, and other core and content courses provide additional high quality support; the teachers are trained in EL strategies, instructional framework alignment, data analysis, and DOK instructional practices. SEL integration into instructional practices, parent and student events, parental engagement actions are targeting students who are disengaged, underperforming, or struggling (structurally disadvantaged). Equity work targets structurally disadvantaged students by improving equitable instructional practices, discipline practices, policies, and procedures. Also, equity work aligns with the parental engagement events and actions.

  - o This amount is the total of the Estimated Actual Expenditures for Contributing Actions (LCFF Funds)
- Difference Between Planned and Estimated Actual Expenditures for Contributing Actions (Subtract 7 from 4)
  - This amount is the Total Estimated Actual Expenditures for Contributing Actions (7) subtracted from the Total Planned Contributing Expenditures (4)
- 5. Total Planned Percentage of Improved Services (%)
  - o This amount is the total of the Planned Percentage of Improved Services column
- 8. Total Estimated Actual Percentage of Improved Services (%)
  - This amount is the total of the Estimated Actual Percentage of Improved Services column
- Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)
  - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8)

- 10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 + Carryover %)
  - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover Percentage from the prior year.
