

## **Budget Overview for the 2023-24 School Year**




This chart shows the total general purpose revenue Gateway International School expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Gateway International School is \$10,157,396, of which \$7,822,838 is Local Control Funding Formula (LCFF), \$1,509,646 is other state funds, \$478,350 is local funds, and \$346,562 is federal funds. Of the \$7,822,838 in LCFF Funds, \$2,047,306 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



## **Plan Summary [2023-24]**

#### **General Information**

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

This charter public school called Gateway International School (GIS or Charter School), is operated and overseen by Gateway Community Charters (GCC), a 501c3 non-profit charter management organization (CMO). The school is governed pursuant to the bylaws adopted by the incorporators, as subsequently amended pursuant to the bylaws. The GCC Board of Directors believes that learning best occurs when students are provided an educational program that challenges and motivates everyone to achieve their full potential.

Gateway Community Charters has been in operation since 2003 in a dynamic partnership with local communities, creating innovative public school choice options, through the charter school construct. Now in their 20th year of operation, they serve over 4,500 students and 500 employees within 9 separate charter schools, all with unique missions and focus. GCC charter schools serve predominantly underserved, vulnerable and at risk students; including English Learners, socioeconomically disadvantaged, 5th year seniors, foster and homeless. Gateway Community Charters manages a complex budget of over \$74 million dollars and has maintained above the required 3% reserve for each of its charter schools as well as keeping an additional reserve as needed for facilities, cash flow, and additional budget sustainability all while expanding enrollment by at least 4% over the last year.

Gateway International School is located in Sacramento County in the Arden-Arcade community. GIS has 580 students enrolled in February 2023 with the following ethnic distribution: 86.2% white, 5.8% Hispanic, 2.8% African American, 0.9% Pacific Islanders, 1.1% Asian, 0.4% Filipino, 1.9% multi- racial, and 0.9% as race/ethnicity unknown. Of those students, 63.7% are socioeconomically disadvantaged, 61.1% are English language learners, and 4.4% are students with disabilities. The majority of students attending GIS are from Russian or Ukrainian families.

GIS has 84 employees; 36 certificated and 48 classified. Certificated staff consists of a Principal, Vice Principal, two Instructional Coaches, School Counselor, School Psychologist, Speech Therapist, Resource Specialist and 26 highly qualified teachers. The classified staff consists of office personnel, custodians, para-educators, and playground assistants. GIS has a full-time RSP specialist, a PE teacher, a Visual and

Performing Arts teacher, a Russian teacher, and a Spanish teacher. There are 11 males and 73 females on staff. Thirty-eight staff members are bilingual in Russian and/or Ukrainian, five are bilingual in Spanish, two in Punjabi and Hindi, two in Fijian and one staff for each of these languages; Farsi and German, Turkish, Hmong, and ASL. Some of the staff are fluent in three languages.

GIS offers an afterschool program funded through the ASES grant and is attended by approximately 300 students on average each day. This program provides a safe environment for students, as well as, enrichment program and homework support and dinner. It is supervised by the ASES Supervisor and a staff of 16 people.

The El Dorado Charter SELPA supports GIS in meeting the needs students with disabilities by providing professional learning to staff and administrators, Alternative Dispute Resolution tools and assistance, facilitation of root cause analysis for Program Indicator Review and other Special Education accountability measures, and access to program specialists and other technical experts to assist with specific student needs.

#### **Reflections: Successes**

IB- GIS is an authorized IB school for the Primary Years Program (PYP) and Middle Years Program (MYP). This school year we went through MYP evaluation visit for MYP.

School culture-83% of students feel teachers encourage collaboration, 96% of parents feel teachers encourage student collaboration, 100% of parents feel teachers encourage students regularly, 82% of staff feel safe at school, 85% of staff is satisfied with school leadership.

ASES-GIS has successfully run the After School Education and Safety (ASES) program for the last 6 years. The ASES program allows us to offer daily homework support, enrichment activities, physical activities, and serve supper to nearly 300 students.

CKH-GIS is very proud to be named as a 2022-2023 "National Showcase School" for Capturing Kids' Hearts for the seventh year in a row. This program focuses on building relational capacity with students and staff. In this process, our students and staff were surveyed anonymously and we were visited by outside observers. Overall, students and staff feel this is a safe and comfortable place to work and learn. GIS employs adequate staff for supervision around the campus and kids can always find someone if they have a need.

Community-GIS offers multiple events to families throughout the school year. This includes Back to School Night, IB Night, two Parent Workshops, School Site Council/DELAC meetings, Talent Show, Winter Celebrations, Spelling Bee and Open House and Book Fair along with Careers on Wheels. Our 8th graders worked on Community Projects for IB and 5th graders completed Exhibition. They worked on these

projects most of the year and presented to fellow students. Student achievements weren't forgotten with an exciting monthly student assembly where students were recognized for their academic and citizenship efforts.

#### **Reflections: Identified Need**

CAASPP-The most recent CAASPP data from 2022 shows that our students have dropped in both Math and ELA. ELA dropped by 7 points but math had a significate drop by 13 points. For the 2021-22 school year, GIS has multiple substitutes teacher the middle school mathematics which could be one of the reasons for the drop. Additionally, the pandemic caused learning loss leading to drop in both ELA and math.

Social Emotional Health (SEL)-Based on both parent suggestions through surveys and during our School Site Council and DELAC meetings, and the student needs identified by the staff, we hired a full time Counselor and provided School Psychologist support, as well as, small group and whole class lessons for social skills.

Chronic Absenteeism- For 2021-22 school year, chronic absenteeism increased to 27.7% (very high) due to COVID-19 related illness and mandated quarantines. We've continued virtual support for students on independent study during quarantine and/or illness, and maintained online learning platforms to support consistency for instruction. We also held Student Study Team (SST) meetings with parents that have chronically absent students to discuss the importance of school attendance.

Academic Achievement- To address learning loss and support students, GIS continues to use an online intervention called iReady, which is Individualized Instruction for all students. To further support our students, TurtleEd, a virtual tutoring program with a live tutor and small groupings, was implemented to support students in need of math instruction, and we've extended the contract to include ELA for our ELD students after reviewing the data of successful learning from the prior participants. GIS also added additional staffing for targeted intervention during the school day with small group instruction for Reading, built an individualized instruction time into the middle school schedule for all students including those who are excelling, and offer after-school tutoring from our certificated teachers.

GIS meets regularly with the School Leadership Team to review data and determine needs and effective strategies. We review data from all programs to see if they are working for students and how we might adjust to make processes more effective and improve outcome. Worked closely with LTL360 to concentrate on improving the teachers' competency and targeting the students' needs.

#### 2023 Educational Partners Survey data:

#### A description of the aspects of the LCAP that were influenced by specific input from educational partners.

Goal 1-College and Career Readiness-Our school counselor presented college and career readiness lessons to all grade levels, supported families with admission to high school, resulting in the highest number of students admitted to IB high school programs, students took a college field trip, Careers on Wheels visitors, and hosted a career day. Additionally, MYP students engaged in career interest surveys, college budgeting activities, mock interviews, and planned for life after school.

Goal 2-Academics-GIS welcomed many displaced families due to the Russian/Ukrainian war. With this, we added two additional para-professionals to provide translation support. GIS continued utilizing the ELA Intervention Teacher to support learning gaps. According the the CA Dashboard, our EL Progress shows 60.5% making progress towards proficiency (very high). This number decreased by 4.9% from the 2019 CA Dashboard data.

Goal 3-School Culture-GIS hosted monthly assemblies and activities for the school to teach children about bullying and its many forms: physical, emotional, psychological, and cyber. These assemblies were in direct alignment with the concern raised by students and parents/guardians in regards to lack of respect between students.

GIS made good progress in meeting the goal to provide conditions of learning to allow all students to develop college and career readiness. There are no substantive differences in planned actions and actual implementation.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

- 1.1 GIS did spend more on standards-aligned textbooks as we adopted new curriculum for science and social studies for elementary and middle school. We have also started to order new curriculum for our Russian World Language.
- 1.2 GIS invested more on classroom materials and tech support as there was a need to update old technology.
- 1.4 GIS trained five additional teachers in Project GLAD.
- 1.5 GIS also did not use all of the World Language and Visual and Performing Arts funds as we were not able to find an art teacher.
- 1.9 GIS did not budget for furniture but ended up needing to replace and update some furniture throughout the classrooms and offices.

An explanation of how effective the specific actions were in making progress toward the goal.

All students at GIS participate in the International Baccalaureate Program which is a program that prepares students for college and Career Readiness. IB, PLTW, and GLAD teach students the necessary skills to be competent, life long learners. All students at GIS had their basic educational needs met including supervision, textbooks, facilities, technology, and instruction to be successful in these programs. GIS continues to train teachers in IB and GLAD every year increasing teachers' capacity in IB and GLAD so they are all highly-qualified and meet state requirements. The IB program requires that students have a well-rounded education with exposure to world language instruction, visual and performing arts, and technology. GIS provided Russian and Spanish language instruction and art or music for all students. There is adequate

supervision at all points on campus, every time of the day. We are going to train all teachers in ELD standards next school year to support our English learners.

This goal serves priorities for standards based instruction and academic outcomes for all students, including those performing below grade level, foster youth, & SED students. It provides staffing support including Vice Principal, two Instructional Coaches, teachers, and paraeducators. Students were provided supplemental materials for academic support and engagement for reading, math, and science. This goal also provided after school program, tutoring, tools for assessment, and summer school. We reclassified 11.5% of our English Learners from the 2022 Summative ELPAC testing. This is a significant growth towards our desired learning outcomes which was only 5%. We saw good progress from the beginning of the year to the end of the school year in both schoolwide & specific subgroups.

We utilized the Second Step curriculum to aid in this goal, as well as, provided teachers with professional development. We also used incentives through PBIS, assemblies, and off site experiences through field trips to motivate students to attend and be engaged. We communicated to families by maintaining a website with calendars, reminders, newsletters, teacher and program information. We recruit students through the community using various methods, including Inside Sacramento, Facebook, and emails.

GIS considered the needs of students, whole school and subgroups, by looking at local assessment data. The needs of all at-risk students including, foster youth, English learners, and low-income students were considered when creating plan goals and actions. We garnered input from families, students, and teachers who know the student needs best. We then created a plan and services that address these needs in response to their feedback. The addition of the full time counselor was very beneficial to the site considering the intense social emotional support needed for students and staff after the pandemic. GIS also saw a significant increase in student academic achievement for Reading and Math based on the local assessment results from i-Ready. The subgroups all grew at a greater rate than school wide rate.

A description of how services for foster youth, English learners, and low-income students are being increased or improved by the percentage required.

- Low class size ratios allows teachers to work more one-on-one with students, including at-risk students.
- Instructional Coach ensures that teachers are given great first time instruction and using data to plan instruction.
- Computers and hot spots supports students accessing online grade level appropriate curriculum at school and at home.
- Training teachers in GLAD builds their capacity to provide supports for English Learners.
- World Languages and Visual and Performing Arts supports students native language and keeps them engaged and attending school
- Bilingual paraeducators provide individualized support for students who need translation.
- After school program and tutoring provides more instruction time for those students who need to catch up.
- Programs help create a positive, supportive, respectful environment for staff and students.
- CKH helps build positive relationships between staff and students.
- Diversity, Equity, and Inclusion data helped focus of subgroups
- Parent Liaison setup to online platforms and is a communication bridge between families and teachers

The LCAP development process serves three distinct, but related functions:

# **Goals and Actions**

However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])
