Student Drop-Off  
Upon drop-off, students are to go directly to class when they arrive at school. Student drop-off begins no earlier than 8:00 am and ends no later than 8:30 am (if starting 11/16 or 11/30).

### Student Pick-Up

Parents cannot leave their vehicles. A school staff member will approach their vehicle and ask for the student's and teacher's name. The staff member will then call that student out of class. Younger students (KG-1) will be walked to the vehicle. Students will be required to wear a mask while walking to their parent/guardian vehicle. Parents are required to arrive at the school site within 15 minutes of the completion of class to pick up their child(ren). All students are to be picked up at their assigned sites (all locations listed below) and cannot meet their siblings at another location.

Skvarla pick-up (KG-1st). From Skvarla parking lot.

Camellia pick-up (4th grade). From Camellia parking lot.

Dudley B pick-up (1st and 2nd). From Dudley B parking lot.

Rafferty A pick-up (3rd, 4th and 5th). From Rafferty A parking lot.

Rafferty B pick-up (4th and 5th). From Rafferty B parking lot.

Portables pick-up (5th). From the Theater parking lot.

Pavilion pick-up (2nd). From Pavilion parking lot and Roundabout.

### COA Middle School:

#### Student Drop off:

When dropping off students all gates on campus will be open and parents and guardians are encouraged to drop off their students in locations that allow physical distancing and lighter foot traffic reminding their students to give space between themselves and others when entering the gates.

Students will walk to their assigned classrooms.

#### Student Pick up:

In an effort to limit the size of the gatherings at pick up time, COA Middle School has developed the following system to limit gathering size and allow for a smooth pick up process.

Students will remain in their classrooms or spread out with their classes in various locations and when a parent is in the pick up area, the teacher will be notified via a mobile app and release the student to safely walk to the pick up location identified by the parent. Multiple pick up locations will be available around the campus.

- X **Face Coverings and Other Essential Protective Gear:** How CDPH's face covering requirements will be and enforced for staff and students.satisfied

All staff and students will be required to wear a face covering at all times, including outdoor activities regardless of social distancing, unless exempted with a note from a medical doctor. Face coverings will only be removed for meals, snacks, naptime, or when it needs to be replaced. Students or staff who come to school without a face covering will be provided one. If a student or staff member refuses to wear a face covering they will be asked to leave campus and only allowed to return when they comply with the face covering requirement.

- X **Health Screenings for Students and Staff:** How students and staff will be screened for symptoms of COVID-19 and how ill students or staff will be separated from others and sent home immediately.

Staff and students will conduct home health screenings. If a staff member or student should exhibit symptoms while at school, they will be removed immediately to the isolation area and arrangements made for the staff member or student to go home.

- X **Healthy Hygiene Practices:** The availability of handwashing stations and hand sanitizer, and how their safe and appropriate use will be promoted and incorporated into routines for staff and students.

Hand sanitizing stations are available in high traffic areas of campus ie next to playgrounds and classrooms without sinks. Hand sanitizer dispensers are located inside every classroom and in common spaces (ie offices and work rooms). Staff and students have been trained on proper hygiene practices, including hand washing for at least 20 seconds, not touching their face with unwashed hands, covering their mouth when coughing or sneezing.

X **Identification and Tracing of Contacts:** Actions that staff will take when there is a confirmed case. Confirm that the school(s) have designated staff persons to support contact tracing, such as creation and submission of lists of exposed students and staff to the local health department and notification of exposed persons. Each school must designate a person for the local health department to contact about COVID-19.

A COVID 19 response team has been created consisting of the health team, central office staff and human resources staff. The health team (School nurse and LVN) have been assigned as the designated contact for the local health department and conduct all contact tracing in conjunction with the central office staff and human resources staff. When a confirmed case is discovered the school staff email the COVID 19 response team with all pertinent information. The COVID 19 response team then begins the contact tracing and notification process.

X **Physical Distancing:** How space and routines will be arranged to allow for physical distancing of students and staff.

Each school campus has put measures in place to increase physical distancing in hallways, classrooms, walkways, bathrooms, and other areas of the campus. Students will be encouraged to not congregate together especially in high traffic areas.

Classrooms on all campuses have been redesigned to maximize the space between students. Desks are separated or put into a formation that allows physical distancing and space to move around.

Clear glass stations are available for the teachers desk and work areas in order to meet with scholars on an individual basis.

Outside areas have been established for outdoor learning and staff is encouraged to take advantage of it as much as possible.
