X **Stable group structures (where applicable):** How students and staff will be kept in stable groups with fixed membership that stay together for all activities (e.g., instruction, lunch, recess) and minimize/avoid contact with other groups or individuals who are not part of the stable group.

Students will come to school for 4 hours per day according to the schedule. The school will limit the number of the students during this phase to allow time to train small cohorts of students to use proper hygiene, distancing, and campus navigation and movement. The students will be oriented and trained how to enter and exit the site, drop off and pick up, wearing face coverings on site, moving between classes, and using common areas.

X **Entrance, Egress, and Movement Within the School:** How movement of students, staff, and parents will be managed to avoid close contact and/or mixing of cohorts.

The students must arrive no more than 15 minutes early before class time and must be picked up or leave no later than 15 minutes after class. If a student arrives early, he/she should stay in the car under parental supervision or stay outside by the classroom maintaining six feet distance from other students. The students will stay in the class with the instructor until they are picked up or dismissed from the class. The students will enter the campus through external gates or will go directly to their classroom from the parking lot. Each student will have a designated entrance point to reduce traffic. For example, the students

who have classes downstairs facing the front parking lot will enter the classes directly through the external classroom door; students who have their first class downstairs inside the school yard, will enter the site through the side gate and then external classroom doors. Students who have their first classes upstairs will be divided and directed through the gates that will be designated by the school staff.

The students must arrive no more than 15 minutes early before class time and must be picked up or leave no later than 15 minutes after class. If a student arrives early, he/she should stay in the car under parental supervision or stay outside by the classroom maintaining six feet distance from other students. The students will stay in the class with the instructor until they are picked up or dismissed from the class.

The students will be dismissed to leave the campus the same way they entered in the morning.

During passing periods, the students will be directed to use designated routes to reduce traffic and ensure safe distancing when possible.

Breakfast and lunch will be served to students in their classes. Lunch times will be staggered 15 minutes apart to allow students to take a break and go to the bathroom. There will be designated spaces outside such as the field, upstairs patio, and blacktop for the students to take break and exercise if desired. The students will have sufficient space to maintain social distance during breaks.

The school day is shortened to allow deep cleaning of all classrooms and common areas daily after the students are dismissed.

- X **Face Coverings and Other Essential Protective Gear:** How CDPH's face covering requirements will be and enforced for staff and students.satisfied

All staff and students will be required to wear a face covering at all times, including outdoor activities regardless of social distancing, unless exempted with a note from a medical doctor. Face coverings will only be removed for meals, snacks, naptime, or when it needs to be replaced. Students or staff who come to school without a face covering will be provided one. If a student or staff member refuses to wear a face covering they will be asked to leave campus and only allowed to return when they comply with the face covering requirement.

- X **Health Screenings for Students and Staff:** How students and staff will be screened for symptoms of COVID-19 and how ill students or staff will be separated from others and sent home immediately.

Staff and students will conduct home health screenings. If a staff member or student should exhibit symptoms while at school, they will be removed immediately to the isolation area and arrangements made for the staff member or student to go home.

- X **Healthy Hygiene Practices:** The availability of handwashing stations and hand sanitizer, and how their safe and appropriate use will be promoted and incorporated into routines for staff and students.

Hand sanitizing stations are available in high traffic areas of campus ie next to playgrounds and classrooms without sinks. Hand sanitizer dispensers are located inside every classroom and in common spaces (ie offices and work rooms). Staff and students have been trained on proper hygiene practices, including hand washing for at least 20 seconds, not touching their face with unwashed hands, covering their mouth when coughing or sneezing.

- X **Identification and Tracing of Contacts:** Actions that staff will take when there is a confirmed case. Confirm that the school(s) have designated staff persons to support contact tracing, such as creation and submission of lists of exposed students and staff to the local health department and notification of exposed persons. Each school must designate a person for the local health department to contact about COVID-19.

A COVID 19 response team has been created consisting of the health team, central office staff and human resources staff. The health team (School nurse and LVN) have been assigned as the designated contact for the local health department and conduct all contact tracing in conjunction with the central office staff and human resources staff. When a confirmed case is discovered the school staff email the COVID 19 response team with all pertinent information. The COVID 19 response team then begins the contact tracing and notification process.

X **Physical Distancing:** How space and routines will be arranged to allow for physical distancing of students and staff.

Students will have a hybrid block schedule reducing movement between classes. The students will have three longer periods a day and will use designated pathways to minimize traffic and allow for appropriate social distancing.

We will maximize space between seating and desks, arrange seating to minimize face-to-face contact, and use physical partitions where needed to ensure at least six feet of separation.

We will distance the teacher and other staff desks at least six feet away from student desks.

We will develop instructions for maximizing spacing and ways to minimize movement in both indoor and outdoor spaces that are clear and safe for students.

We will use clear desk partitions to increase and enforce separation between staff and scholars.

The students will use assigned seating in each classroom.
